Information sheet

Verification of periods of training and employment as well as possible gaps in the background check in accordance with Section 7 LuftSiG in conjunction with No. 11.1.3 c of the Annex to the Implementing Regulation (EU) 2015/1998

Regarding point 11.1.3. c of the Annex to the Implementing Regulation (EU) 2015/1998, a background check in the aviation security sector includes at least the recording of all employment relationships, education and training and any gaps during at least the last five years prior to the application. Until now, the Aviation Security Authorities in Germany had refrained from requesting evidence of the specified periods or gaps in detail or had limited checks to random samples. The European Commission has ordered Germany to implement the above-mentioned EU regulation in full from 1 January 2021 at the latest as part of the processing of applications for verification of reliability under Aviation Security Law for each individual application.

In order to ensure that your application for an Airport ID Card is processed quickly, we ask you to ensure in particular that the application is accompanied by meaningful documents that clearly show the periods of employment, training and further education and any gaps of more than 28 days within at least the last 5 years prior to the application.

This means in detail:

- The information on periods of employment, training and further education must be stated with the start and end of the activity (chronologically and to the day). In the case of existing employment relationships, a current confirmation of the duration of employment is required.
- The relevant supporting documents must be enclosed with the application. Proof of professional activities must be provided in the form of suitable copies. Periods of employment can be proven in particular by employment contracts, employment references, social security certificates, business registrations (with a current confirmation of the existence of the business).
- Periods of training can be proven, for example, with proof of training, certificates or attestations of an acquired qualification, provided that the period is shown.
- Gaps in the employment history exceeding 28 days must also be stated and documented with appropriate evidence. For example, proof of unemployment (copy of the approval notice and, if applicable, the cancellation notice) or receipt of care allowance can be enclosed. In the case of longer journeys, a copy of the passport with the corresponding endorsements can be submitted, for example.

The background check in accordance with § 7 LuftSiG can only be finalised if the employment relationships, training and further education and any gaps in the last five years at least prior to the application have been listed and documented. If you refuse to submit documents via your employer for reasons of data protection, you are free to submit the supplementary documents for the ID card application in a sealed and appropriately labelled envelope.

If the ID card application is submitted incompletely, this leads to delays in processing time and increased costs.

Information sheet on the application for a background check in accordance with Section 7 of the Aviation Security Act (LuftSiG)

Dear Sir or Madam,

Due to Regulation (EU) No 2015/1998 which entered into force on 5 November 2015 laying down detailed measures for the implementation of the common basic standards on aviation security, Landesbetrieb Mobilität Rheinland-Pfalz, as the responsible Aviation Security Authority of the State of Rhineland-Palatinate, requires further proof of all applicants who are resident in the following countries as part of the background check

currently reside abroad or have lived abroad in the last ten years.

In the case of residence (longer than six months) in the last five years, a Certificate of Good Conduct from the foreign country of residence is required.

Such proof is a Police Clearance Certificate of Good Conduct from the country of residence or the former country of residence. For residences within the EU, no legalisation in the form of an Apostille or Hague Apostille is required.

In the case of residence in a non-EU country, legalisation in the form of an Apostille or - for corresponding countries - a 'Hague Apostille' is required.

The Hague Apostille Convention only applies to certain countries in relation to Germany:

For countries where this does not apply, legalisation must be requested. Further information on the subject of apostilles and legalisation can be found on the homepage of the Federal Foreign Office.

The Certificate of Good Conduct or the Certificate of No Criminal Record must be applied for via the embassies or consulates of the country of residence.

The respective documents must be attached to the application for a background check in the original with an officially certified translation into German.

The Certificate of Good Conduct or the Certificate of No Criminal Record must always be reapplied for in the event of future re-examinations if the applicant is permanently resident abroad.

If no Police Certificate of Good Conduct or Certificate of Clearance from the relevant country can be presented, the application for a background check cannot be processed.

As the person concerned, the applicant is obliged to co-operate in the review in accordance with Section 7 (3) sentence 2 LuftSiG.

If the applicant does not fulfil their obligation to cooperate, their reliability must be denied in accordance with Section 5 (1) sentence 2 of the Aviation Security Reliability Verification Ordinance (LuftSiZÜV).
