A Declaration of the Applicant Company / Authority

The applicant company / authority affirms that

- the details overleaf have been truthfully supplied,
- the details of the vehicle are complete and agree with the vehicle document specified,
- the driver is in possession of a valid airport pass
- the driver is in possession of a valid driving license
- the Vehicle Pass is necessary for the performance of official duties,
- only those areas are allowed to enter that actually need to be entered in the performance of the applicant's duty/work,
- the Vehicle Pass will be duly returned or the company /authority will otherwise pay the fee envisaged for this

The Vehicle Pass is property of the airport Frankfurt-Hahn GmbH and must be returned immediately, if it becomes invalid or other conditions for ownership no longer apply (§ 18 German Air Security Act, failure to return the ID constitutes a misdemeanour, which will be prosecuted!).

The applicant company / authority affirms that

- the driver is holder of a required work / resident permit, a copy is attached to the Airport Pass application
- they will bear the costs of processing the application and issuing the Vehicle Pass,
- they will bear the costs for the period of use applied overleaf, indexed in the List of Service Charges of Frankfurt-Hahn GmbH
- the ID Card Services of the Frankfurt-Hahn airport will be informed if the employment contract with the pass holder expires, the holder is no longer employed at the airport or other conditions for possession of this pass are not satisfied
- the pass will be duly returned or the company /authority will otherwise pay the fee envisaged for this

The signatory is authorized to sign for the company / authority named overleaf.

The specimen signature is stored at the ID Card Services of the FFHG. The activities at the airport Frankfurt-Hahn are permitted by the airport Frankfurt-Hahn GmbH.

B With companies: Customer Confirmation

I confirm that

- the applicant company named overleaf is active on our authority at the Frankfurt-Hahn airport.
- in as much as our contractual relationship to this company should expire or the activity commissioned by us at the Frankfurt-Hahn airport should no longer be necessary, we will inform the ID Card Services of the airport Frankfurt-Hahn GmbH immediately in writing.
- the statement of the employer and the applicant, if possible, are examined and will be confirmed.

C Declaration of the Applicant Person upon Application for a Vehicle Pass

I consent to my personal details being stored electronically.

I acknowledge the Airport User Regulations and the ID Regulations.

I am aware that

- the Vehicle Pass may only be used for official purposes,
- the Vehicle Pass should be kept in a safe place and any loss or suspicion of loss must be reported immediately to the ID Card Services (Phone +49-6543-509133) or to the airport security service (Phone+49-6543-509160),
- additional passengers in the car have to be holder of a valid access authorisation
- the Vehicle Pass is the property of airport Frankfurt-Hahn GmbH and must be returned if the pass becomes invalid or the conditions for ownership no longer apply (§ 18 German Air Security Act, failure to return the ID constitutes a misdemeanour, which will be prosecuted!) and
- if the Vehicle Pass is damaged, I will immediately inform the ID Card Services of the FFHG and have to return the damaged pass.

The driving person is aware of the Road Traffic Regulation and the German Air Traffic Act at the airport.

Driving on the air side area is only permitted after passing the training course and receiving the authorization by the airport Frankfurt-Hahn GmbH.
